The Secretary / Correspondent, **Jagruthi Educational Society, Ramanjaneyapuram, Chinna Chowk, Kadapa, 516002, A.P** has applied for Extension of Permission for Private Un-Aided Degree College **Sri Venkateswara Degree College, Thadipatri Road, Muddanur, Kadapa District, 516380, A.P** vide ref 4th cited.

After careful scrutiny of the proposal as per rules in vogue, the AP State Council of Higher Education, in exercise of the powers vested in it vide ref 2nd cited, r/w rule 9(2)(b) of G.O Ms.No.29 dated.05.02.1987 hereby accords provisional Extension of Permission (EoP) to **Sri Venkateswara Degree College, Thadipatri Road, Muddanur, Kadapa District, 516380, A.P** run by **Jagruthi Educational Society, Ramanjaneyapuram, Chinna Chowk, Kadapa, 516002, A.P** for the academic years **2020-21 & 2021-22** for the following programmes/combinations as per the details given below:

The provisional Extension of Permission accorded is subject to the fulfillment of the following conditions:

- The Management has to shift to own and permanent accommodation before the expiry of this permission and obtain necessary approval from the Government/Council to run the College in own premises. This condition may kindly be treated as notice to the College and if the college fails to shift its accommodation, the Competent Authority has the authority to withdraw permission.**
- The College (a) shall not shift to any other place; (b) shall not change the name of the College, (c) shall not transfer the management of the College and (d) shall not convert Women's College to Co-Education and vice-versa till it is shifted into own building and such shifting/transfer/conversion is unauthorized as per rules in force.**

- 3 The APSCHE has the authority and reserves the right to withdraw the permission, at any point of time, on any action of the Management / College which damages or causes disrepute to Govt./Univ./Council.
- 4 The management shall obtain prior approval of affiliation for the College, Programmes with Combinations, Intake and Medium of instruction, from the concerned University during the academic years 2020-21 & 2021-22, failing which the Extension of Permission accorded is deemed to be cancelled without any further notice.
- 5 The management shall follow the rules issued by the Government / Competent Authority from time to time on all aspects related to the administration of the college.
- 6 The accommodation shown for Degree College shall not be used for any other purpose other than running the degree college for which permission is given by the APSCHE.
- 7 The management shall not change the Programmes / Combinations, intake and media sanctioned in these proceedings failing which, such action will be construed as tampering of records for which APSCHE will initiate necessary legal action against the Management.
- 8 The management of the College shall set up a grievance and complaints cell as per the Supreme Court / UGC guidelines for dealing with sexual harassment / ragging related cases and other grievances etc.
- 9 The management shall put in place a "Students Counselling System" for effective redressal of problems and challenges faced by students to bridge formal and communicative gap between students and institution.
- 10 The Managements shall also organize orientation programs for spreading awareness on the ills of tobacco, alcohol and drugs.
- 11 The Management shall implement UGC Regulations and sensitise the students on ill effects of junk food so that the students live better and learn better. It also aids in reducing obesity levels in young learners, thus preventing life style diseases.
- 12 The management of the College shall not affiliate itself to any University outside the State of Andhra Pradesh and run the programmes of other State University in their premises under Section 21-A of A.P. Education Act 1982, failing which, the Managements shall face criminal action under Section 21-A of AP Education Act.
- 13 The management shall establish a website for the college and keep all the necessary academic and administrative information in the website.
- 14 APSCHE reserves the right to conduct surprise checks at any time. The Council also reserves the right to cancel permission / affiliation of the college at any stage, if it is found that the documents produced by the management are false, interpolated and improper and the management is not able to run the college as per the norms of the Government and academic stipulations of the concerned University, apart from any defaults/ irregularities committed which would attract legal proceedings under Law.
- 15 All conditions issued in the original permission order by APSCHE for establishment of college remain unaltered.
